DONOR RECOGNITION RECEPTION SET FOR OCTOBER 12

Although Imagine! is 44 years old, its fundraising arm, the Imagine! Foundation, just celebrated its sixth birthday. It has been a busy and productive six years, and the Foundation will this year reach the \$2,000,000 mark in donations, so it seems to be a fitting time to recognize in a permanent way those individuals and companies who have given so generously to help Imagine!'s consumers.

Local artist John Haertling of Haertling.com is creating a Donor Recognition area in the Imagine! Coal Creek Conference Center's foyer. A wall display will honor all donors who have contributed a cumulative gift of \$5,000 or more since the Foundation began fundraising in 2001. A mountain-like sculpture will name members of The Imagine! Promise – those who have included Imagine! in their wills. Two of the three large conference rooms in the building have been named and will display their new signage.



Walt and Linda Pounds (shown here with their daughter Cari) will be honored for their substantial support of Imagine! by having a conference room named after them in Imagine!'s new Coal Creek Conference Center. A ceremony marking the room naming and honoring other Imagine! donors will take place on October 12.



One of the new conference rooms in Imagine!'s Coal Creek Conference Center will bear the names of Betty and the late Tom Eldridge (pictured above with an Imagine! consumer in front of a wheelchair accessible van they helped purchase for Imagine!) in honor of their generous support of Imagine! over the years.

The west conference room has been named for Walt and Linda Pounds, and the east conference room will bear the names of Betty and the late Tom Eldridge. A "Book Nook" will feature a book listing all Imagine! donors for the previous year, and an "Imagine! That" publicity wall will complete the lobby area. On Friday, October 12 from 5:00-7:00 PM, the Foundation will welcome all donors to its first Donor Recognition Reception in the Coal Creek Conference Center, 1665 Coal Creek Drive in Lafayette. TWO SMARTHOMES NOW PLANNED!



SmartHome

Imagine! is currently planning to build two SmartHomes in Boulder County—one in Boulder and one in Longmont. As the first such homes in the nation, they will serve as demonstration models for the future of residential care for people with cognitive disabilities, once again demonstrating Imagine!'s penchant for providing cutting edge services based on the latest research in the field.

Imagine!'s SmartHome Project has doubled! Due to the significant need and interest in a SmartHome for Imagine!'s consumers, Imagine! and the Imagine! Foundation are now planning to create two SmartHomes – one in Boulder and one in Longmont. The SmartHomes will incorporate cutting edge residential technologies to enhance the quality of life for clients, augment the effectiveness of staff as caregivers, and provide cost and energy savings for Imagine!. As the first such homes in the nation, the SmartHomes will serve as demonstration models for the future of residential care for people with cognitive disabilities, once again demonstrating Imagine!'s penchant for providing cutting edge services based on the latest research in the field.

The original plan was to build one SmartHome in Boulder, but new Imagine! Foundation board member Leona

Stoecker, former mayor of Longmont, has been instrumental in working with the City of Longmont, Thistle Community Housing, and the Longmont community to secure a lot for a six-person SmartHome in the new Blue Vista Neighborhood being developed in the southeast section of Longmont. Imagine! has recently submitted a federal grant application for approximately \$630,000 to the Department of Housing and Urban Development for the Longmont SmartHome project, and fundraising in the community has already begun.

Boulder's SmartHome will be an eight-person home built on a lot near Iris and 19th Streets. Imagine! currently owns and operates a group home on this site, but replacing the 60-year-old home with a new home equipped with "smart technology" will be cost effective, will increase client independence, and will

provide a model of care not only for those with cognitive disabilities but also for other groups of people with related concerns (autism, chronic mental illness, dementia, Alzheimer's) through partnerships with other agencies. The City of Boulder has already indicated its support through an initial grant of \$50,000.

The Imagine! Foundation has been busy securing other grants, donations and in-kind pledges for both homes, such as the generous offer from Peter Heinz of PEH Architects to donate SmartHome plans. The University of Colorado's Coleman Institute for Cognitive Disabilities has also been invaluable in supporting the SmartHome endeavor from the beginning. Longmont's Left Hand Brewing Companies sponsored a Motorcycle Poker Run on Sunday, July 22 to benefit Imagine!. Eric Wallace, president of Left Hand Brewing Companies and an Imagine! Foundation board member, said that 40 people rode the circuit, picking up cards at each stop to complete a poker hand.

The entire proceeds of \$670 were donated to the Imagine! Foundation.

Left Hand Brewing employs several Imagine! consumers who stock Mountain Mixer boxes with four different flavors of the brewery's beer. Mark Sample, Poker Run organizer and packaging manager/brewer for Left

Hand, said that the brewery could have shipped the boxes to Denver to be stocked but that he preferred to keep the operation in-house, and employing Imagine! consumers provided a way to do so. He continued, "We initiated the Poker Run as a way to continue to support the great work that Imagine! does in our community."

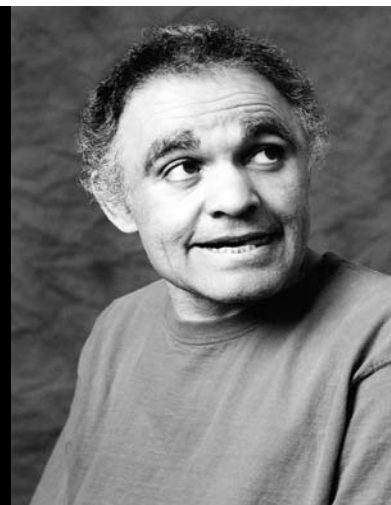
